**Minutes for Meeting Held
October 21, 2006**

Present: Midge Lawrence, Dan Schleiter, Glenn Newville, John Andres, Kyle Cassel. Absent: Karl Frickelton, Patty Devine.

Midge Lawrence called the meeting to order at 10:00 a.m.

A motion was made and seconded to approve the minutes from the Quarterly Meeting held on August 26, 2006. Motion approved unanimously.

Dan reviewed a summary of the Changes in Net Assets for the Period Ended September 30, 2006 and an updated Budget Summary for 2006. Dan is preparing the tax levy for the County. If anyone should get taxed more than once please contact Dan for a refund. The levy is done manually so please forgive any mistakes.

John gave an update on the Lake Management Plan. We have not received as yet approval of the plan from the DNR. We are proceeding as if it's been accepted. A discussion about the treatment for 2007 was had. The Board will be looking at other methods for treating the lake in the future.

Kyle gave a report on the County Lakes Association meetings he has attended. There are 17 bodies of water represented. The purpose of the Association is to share ideas, info, and resources to help the lakes in Adams County.

There wasn't a Chamber report to give per Glenn. He did mention that since he has moved we will need to find someone who lives locally to attend the Chamber meetings.

Midge announced (in Patty's absence) that we have advertisers on the website www.jlrpd.org. Please support our advertisers when you make a purchase.
