Consensus is no wake ordinance is a Jackson Township law, and individuals may choose to notify authorities of violations. The lake district will not get involved with enforcing the no wake restrictions.

General discussion was brought up by Scott Larson regarding low water, and large submerged rock on south west side of lake may need to be permanently marked. Scott Larson will contact DNR, Adams county, and Jackson Township to discuss process of getting hazard marked.

Kyle Cassel gave the County Lakes Association Report- no updates to report. The last meeting was cancelled. Kyle also notified board of prospective donation of funds to stock lake. Scott Larson volunteered to contact DNR and hatcheries to put forth stocking/habitat recommendation for our lake.

The Web Site Report was given by Scott Larson.

Motion was made and seconded to empower Karl Frickelton to find appropriate clubs, school associations to man the clean boats clean waters time slots we have open, if needed. Motion passed unanimously.
