

JORDAN LAKE REHABILITATION and PROTECTION DISTRICT  
MINUTES for QUARTERLY MEETING held March 18, 2017

Chairman Karl Frickelton called the meeting to order at 10:08AM.

A motion was made and seconded to approve the minutes of the meeting held on October 15, 2016. Motion was approved unanimously.

There was general discussion regarding the results of the fall survey from the Cason and Associates study, which concluded the milfoil was back. There was general discussion of options for milfoil management of the lake which included whole lake treatment or spot treatment of the lake. Whole lake treatment of Eurasian Milfoil was proposed by Chairman Karl Frickelton. General discussion was had by board members. A motion was made and approved to go ahead with pursuing a permit for whole lake treatment of the lake. After the permit is issued and before treatment of the lake, the members of the district will need to be notified by a mailing and a public notice in the paper. It was discussed to do the required annual meeting mailing at the same time.

Treasurer Dennis Flanagan gave an update on the Treasurer's report.
