There was also general discussion about lake oxygen levels, equipment and grants. Jennifer also took a questionnaire poll on the largemouth bass potential regulation change on Jordan Lake.

Treasurer Dennis Flanagan did not have any additional information to add to the Treasurer's report that was given at the annual meeting.

The chairman of Adams County Lakes Alliance, Eric Edwards from Parker Lake was at the meeting. The lake alliance website is [aclakes.org](http://aclakes.org).
